## **SAILING CLUB PREMISES.**

**NEW HARD:** Two storey clubhouse with two function rooms, toilets/changing rooms, bar and kitchen.

Boat shed for the storage of Safety Boats, with loft storage over. Tractor shed, starting hut and a further store/workshop. Slipway for launching, floating pontoons.

**OLD HARD:** Single storey wooden building with storage and function use, Slipway for launching.

## **Activities:**

Sailing, rowing and canoeing. Storage of dinghies, rowing boats and canoes. Winter storage and lifting ashore of cruisers and other small craft using appropriate launching/recovery and lifting equipment. Social functions including bar, music, dancing, catered lunches, suppers, lectures and talks.

Use of Mobile Crane (Harry Hoist).	Members, guests and visitors may suffer serious injuries if suspended items fall from the Mobile Crane	The Mobile Crane should NEVER be used to lift anything which exceeds the maximum stated load.  Only competent and experienced members should use the Mobile Crane.  Users of the Mobile Crane should always avoid helpers, themselves and others being in a position of danger.	Keep under review. Use of the "A" Frame	Members, guests and visitors may suffer serious injuries if suspended items fell from the "A" Frame.	The "A" Frame should NEVER be used to lift anything which exceeds the maximum stated load. Only competent and experienced members should use the "A" Frame. Users of the "A" Frame should always avoid helpers, themselves and others being in a position of danger.	Carry out regular inspections of chains, ropes etc.	Low	Equipment check required
Working in the boatsheds. Personal injury, electric shock. Falls, trips.	Members working on club boats or personal projects in the boat sheds.	Electric machines tools should properly maintained and only be used by members with sufficient training or experience to use the tools safely.  Any electric heaters to cure epoxy or dry paint etc. should be oil filled and not fan heater type. Paints, resins and other chemicals should be stored and used in accordance with all safety information sheets and procedures.	Ensure all members are aware of the hazards. Cruiser lift-out, winter storage and launching.	Members and public injured during launch and recovery. Special care should be taken when crossing the Public Footpath, posting a lookout protecting the public from the towing cable. Launching, recovery and storage of the safety boats. Greater risk of slips and falls when the slipway is muddy.	Members and public injured during launch and recovery.	Safety boats are not to be hauled up or down the slipway manually. All movements are to be carried out using the Mini Tractor.  Persons engaged in the launching or recovery of the boats are required to be aware of and not to impede members of the general public that may be using the public footpath located at the top of the hard.  Regular cleaning of the hard to minimize the slip hazard. Wear appropriate footwear when launching the boats.	Review procedures regularly. Investigate better ways of launching/recovery, i.e. winch or tractor/car	High	Check that there is an adequate number of trained drivers and that safety boat crews are aware of the new procedures.
Slipway	Members, visitors and guests, from slips and falls	The slipway is cleaned periodically but is very difficult to keep clean. Mud gets dumped at high water and quickly builds up. Sometimes only a single tide leaves it very slippery. Warning signs beside the slipway.	Review improved methods of clearing mud from the slipway.	High	Regular cleaning now carried out. Permanent system WIP
